PERTAINS EXCLUSIVELY TO TOW MOTOR BIDS
The Addendum is not concerned with the Fleet Vehicles portion of the project.

There have been a couple of questions concerning the tow motors (forklifts) that WCS is soliciting bids for. Please see the list of questions and the answers from WCS Technology Department.

- 1. QUESTION: You have a capacity of 4,000 lbs. – 6,000 lbs. as a range for tow motors. This is a very broad range and the cost can be substantial. Please clarify what size WCS needs?**
- 2. QUESTION: There is a big price difference in 36 to 48 volt batteries and Lithium Ion battery is very expensive which do you need?**
- 3. QUESTION: Will this lift be used outside on gravel surfaces or indoors on a smooth concrete floor?**

It is difficult to address these questions and to clarify because WCS will determine what it needs depending on the pricing. Therefore, bidders will find attached to this addendum I a new revised bid cover sheet for this project. Please Discard the previous bid sheet and use this new revised sheet which includes pricing for different size units and batteries for the forklifts.
