**WILLIAMSON COUNTY SCHOOLS

ASPHALT – PAVING UNIT PRICE MAINTENANCE & REPAIRS**

Williamson County Schools is currently accepting sealed bids from licensed and qualified ASPHALT PAVING CONTRACTORS interested in bidding on a Unit Price Maintenance and Repair Contract. The intention of this clarification is to explain the unit price bids for additional “incidental concrete repairs” that are included in the RFB # 1190 Asphalt - Paving Project documents.

On August 14, 2019 at 10:30 a.m. WCS conducted a bid for concrete unit pricing, the title of that bid project was RFB #1180-C *Concrete Continuing Maintenance Contract*. That bid project contained unit pricing for various types of concrete work to be performed by WCS during the next five years. After the bids were opened and tabulated the contract for RFB # 1180-C Concrete Continuing Maintenance Contract was awarded to Sessions Paving Company, Nashville, TN as the successful bidder.

This current bid project RFB #1190 Asphalt-Paving Unit Price Maintenance & Repairs will also include some “incidental concrete repairs”. It should be noted and understood that the projects covered under the previous bid (RFB # 1180-C) are for small, medium and large concrete projects that may occur and are not related to this asphalt paving bid project. Although there are a few unit price items listed in this current bid project (RFB #1190) which are considered “incidental concrete repairs” they may also be covered in the previous bid.

WCS will perform these “incidental concrete repairs” projects at the same time that Asphalt Paving Project is occurring. In order to alleviate time delays, cost increases or incomplete projects WCS reserves the right to contract with the awarded bidder of this current project RFB #1190 Asphalt – Paving Unit Price Maintenance & Repairs for any and all “incidental concrete repairs” that may be part of an overall Paving Project. In the same manner if the “incidental concrete repairs” are such that Williamson County Schools determines the awarded bidder of

RFB #1180-C Concrete Continuing Maintenance Contract should perform the work, it will be at the sole discretion of Williamson County Schools to make that determination on its own behalf.
