project will be awarded to the best, lowest and most responsive bid that successfully passes the bid/qualification process. Johnson + Bailey Architects will assist in the review and bid tabulations and will provide to WCS a written recommendation as to the awarded bidder. After the low bidder is established a bid tabulation will be sent to all participants. Approximately 10 days after the bid tabulations are released, a fully funded-encumbered award PO will be issued by WCS Purchasing Dept. to the low bidder. The encumbered award PO will also give reference to the <u>Notice to Proceed Instructions</u>. The awarded bidder must also provide to WCS the following items within fifteen (15) consecutive calendar days from the date of WCS funded PO.

- Fully executed AlA contract (facilitated through Johnson + Bailey Architects)
- A Payment, Performance, Labor and Materials (PPLM) Bond in the amount of 100% of the contract sum, issued by a bonding company licensed to do business in the state of Tennessee and acceptable to the Owner. Bond is required of the successful bidder to guarantee faithful performance of work under the contract.
- In the event the successful Bidder to whom the contract is awarded fails to execute a satisfactory contract and PPLM bond and proof of insurance then said bidder shall be eliminated and shall forfeit his 5% bid bond and be liable for any loss occasioned to the Owner because of such failure.
- Insurance: WCS must be named as an additional insured on contractor's policy as follows: Contractor will obtain and maintain insurance to protect the contractor and owner from claims which may arise out of or result from contractor's operations under the contract. Certificate of Liability with a minimum of \$2,000,000 listing WCS as additional insured must be provided.
