**IMPORTANT INFORMATION**  
**CONCERNING SPECIFICATIONS**

This Addendum II serves as an integral part of the WCS - RFB #1253 Williamson County Schools District Vehicle Bid document. The date and time will remain Tuesday, August 3, 2021 at 10:30 am. Unless otherwise noted, all previous terms, conditions, and specifications shall remain the same.

**BIDDERS SHOULD DISCARD THE PREVIOUS BID SHEETS**  
**AND USE THE NEW REVISED BID SHEETS**  
**INCLUDED IN THIS ADDENDUM II**

**WCS has included 2 new items to the specifications.** It is not necessary for a bidder to bid on all items. Bidders are free to bid on 1 or all items if available at their discretion.

Each Bidder should keep in mind due to the complex variations in vehicle specifications, especially those that are slightly different between manufactures, WCS does not have the ability to list every exact specification of each manufacturer.

Bidders must take into consideration, WCS has attempted to cover the specifications for items as best as possible, if the bidder is presenting to WCS a slightly different specs, they should just make note of that difference on the bid cover sheet. However, potential bidders, should not take advantage of any unintentional error or omission. Bidders shall fully address the full intent and meaning of each aspect of the specifications or descriptions and provide a vehicle that meets or exceeds the needs of WCS.
