Williamson County Schools (WCS), Owner, is currently accepting sealed bids from licensed and qualified bidders to upgrade the existing HVAC system at Renaissance High School from a boiler/chiller system to a variable refrigerant flow type system with a dedicated outside air unit for ventilation. Plumbing and electrical systems are intended to be changed only as required for the HVAC system upgrade. In addition to the HVAC upgrade, there is a minor architectural renovation that includes adding an office in the basement in the student lounge area.
