**NOTE: Reminder, the bidders should discard the bid cover sheets from the previous documents and use this version when submitting a bid. Because the pricing structure has been changed, all participants must use the revised Bid Cover Sheets attached to this Addendum II document. The bid opening date and time will remain Wednesday, April 12, 2023 at 10:30 am. All other terms and conditions should remain the same.**

- **DUE TO A SCHEDULING & FACILITY ISSUE .....**The dishwasher for **Brentwood High School** has been postponed, the following items have been removed. **ITEM 4-A ITEM 4-B ITEM 4-C ITEM 4-D.**
- **WCS is now asking for pricing using the validated current MSRP plus a percentage discount...the percentage discount should include 100% cost of the labor, materials, supplies, shipping, and removal of current machinery. In other words everything to make this a 100% turn-key project.** All submitted Bids are to be valid for a minimum of 60 days or until awarded whichever comes first. For all awarded bids the original validated **MSRP price structure and discount** will be fixed and remain in effect throughout the entire first year of the contract. At the anniversary date going forward into the second year, the MSRP could possibly change, however the percentage discount (that includes all items to make a turnkey project) must remain the same during that years contract. This project may be renewed at the anniversary date for an additional 3 years which makes this project a 4-year project including the first year of this contract.

**IMPORTANT NOTE: There was a question concerning the delivery and set up of the items. The dealer is allowed to deliver the items to the school and set up, then bring an authorized brand service agent in to make the final connections. However, the submitted bid cost must include all of these services, this is a 100% turn-key project. There shall be no hidden fees or additional cost. All costs associated with the installation shall be included in the final bid price. NO EXCEPTIONS.**
