Contracts for this project will be awarded to the lowest, best and most responsive bid(s) that reasonably meet the specifications and qualifications. Immediately after the bid opening, WCS Purchasing will prepare a bid tabulation, Entech Engineering, Inc. will review the tabulation and will provide to WCS a written (documented) recommendation. WCS will then release the bid tabulations to the bidding companies with our intent to award. After 10 consecutive calendar days WCS will issue a fully funded award PO to the low bidder.

After the successful bidder has received the award notice, said bidder <u>must provide</u> to WCS the following items within (15) consecutive calendar days from the date of WCS award notice.
