Immediately after the bid opening, WCS Purchasing will prepare a bid tabulation, Entech Engineering, Inc. will review the tabulation and will provide to WCS a written (documented) recommendation. WCS will then release the bid tabulations to the bidding companies with our intent to award. After 10 consecutive calendar days WCS will issue a fully funded award PO to the low bidder.
