Envelopes should be marked “**WCS-RFB #1342 Roof Replacement – Portions of Three Schools (RHS, out bldgs at FHS, SES)**”. Faxed or emailed bids will **not** be accepted. **Sealed bids will be received until 10:30 a.m. CST Time Zone on Thursday, March 28, 2024**, at which time they will be publicly opened. Any bid received after the specified opening time will **not** be accepted. In the event WCS must reschedule an RFB opening date or time, the specifications obtained from the Purchasing Dept. shall reflect the actual date and time. Once the sealed bid envelope is submitted to WCS the Purchasing Department will stamp the face of the envelope to authenticate the actual date and time it is received. **A pre-bid meeting will be conducted for this project on Wednesday, March 13, 2024 at 9:00 a.m. CST Time Zone.** The meeting will begin at Ravenwood HS (1724 Wilson Pike, Brentwood, TN 37027) and move to Scales ES and Franklin HS. Visitors must check in at the school office.

Important Note: Only roofing contractors that have been pre-qualified and approved to participate with WCS, through WCS RFQ #1330, are allowed to submit bids for this RFB #1342 project.
