## IMPORTANT INFORMATION

WCS has received a few questions concerning this request for proposal, these questions have been answered and are listed below:

**1. Question:** We are having trouble locating the TI Self-Contained Monitoring Station that you have listed as specifications online. Can you share a link to a website with product information and pricing?

**ANSWER**: The unit we have listed under our specifications is from the Eversafe Solutions Company. Potential proposer can go to the Eversafe Solutions web site to find out more about this unit.

**2. QUESTION**: Should bids include a monitor, keyboard, etc? Some other companies' scanners include a screen that can be monitored in real time, but also include an AI component that can be accessed from any internet connected device.

**ANSWER:** WCS is seeking a unit (scanner) that is plug and play. In other words, one that includes all of the necessary components on a mobile device that can be simply rolled to the locations and plugged in. That means everything necessary would be together in one unit, screen, keyboards etc...

**3. QUESTION**: What level of detail/information are you looking for on our platform's functionality? Will there be an opportunity for select vendors to demonstrate their solution after RFPs are submitted?

**ANSWER:** Time is of the essence! This is an emergency procurement project for WCS. We do not have the luxury of time for multiple discussions and demo's. We are however making appropriate accommodations to conduct a fair and publicly competitive (quick) bid process. This emergency was delegated to WCS Purchasing Dept from WCS senior management with instructions to quickly-facilitate. WCS needs to be able to determine if the unit being proposed complies with the specifications used for an example. Proposers should make sure their unit is equal to or better than the specified example.

**4. Question:** Will solution accuracy, additional features (i.e. mask detection, social distancing enforcement, & contact tracing) be taken into consideration?

**ANSWER:** WCS desires a unit that is comparable to the unit used for the specifications, the main purpose of this RFP is to procure a scanner that will detect someone with an elevated body temperature who is attempting to enter a stadium or gym in a large group of 15-20 people. Other features may be included but are not necessarily needed as long as it serves this purpose.

**5. Question:** If the unit my company sells has a platform that requires internet access via wired ethernet, Wi-Fi, or cellular networks. Will this be an issue for temperature checks at WCS stadiums?

**ANSWER:** All WCS facilities have access to the internet through Wi-fi. It should be noted that the WCS Technology Director will be part of the decision-making team who awards this RFP and will take those issues under consideration. The RFP would not be awarded to any bidder who does not meet the specifications.

**6. Question:** Does the training the awarded Vendor provide to the District have to be done in person or can this be done virtually through a zoom or skype type setting.

**ANSWER**: The training must be done in person at the time of delivery at the designated WCS facility. This designated facility is actually a WCS Training Room. It is designed to allow quality training and presentations for several of our staff members all at the same time.
