



WCS Reopening Framework FAQ: Breakfast and Lunch

My child has been eating breakfast at school purchasing a meal in the food line. Will that continue to be offered?

Not all schools offer a breakfast program. Please contact your school's office to determine if your child's school offers breakfast.

Where will my child eat lunch?

Lunch location will vary depending on the grade level of the school, the configuration of the cafeteria area, and on how many staff are available to properly space and manage the groups of students.

- Elementary schools will have lunch either in their classrooms or in the cafeteria with students spread out and more tables set up in areas adjacent to the cafeteria if possible.
- Middle and High schools have different arrangements based on each school with increased social distancing and additional tables. Please contact your child's school for more information on where they are having students eat. Those high schools who traditionally used the 1-hour lunch period will continue to do so.

If my elementary school child eats lunch in the classroom how will he/she be able to purchase their lunch from the cafeteria?

Schools will use two methods for getting lunch via the cafeteria depending on how much staffing they have. Some schools will be able to send students to the cafeteria to go through the line and get their meal then proceed back to the classrooms. Other schools may need to have students order lunch in the morning from a pre-published menu. The students will have a choice of four different entrees. These meals will be packaged and delivered to the classroom.



Where will breakfast and lunch menus be published?

Menus will be posted on the WCS website. Teachers will fill out an order form with the names of students preprinted so proper charges can be made to the student accounts.

Should I send lunch to school with my child?

Lunch options are at the parent's discretion.

Will the cafeteria area be sanitized between each seating?

Yes.

Will my child be required to wear a mask while going through the food serving line?

Yes.

Will my child be required to wear a mask when transiting to/from the cafeteria?

Yes.

If my child eats lunch in the classroom will the classroom be cleaned after the meal is finished?

Yes. CDC approved cleaning supplies are being provided to each classroom for use during the day as desired/necessary. These supplies will be appropriate for post-lunch spot cleaning, as necessary.

Will school meals be offered if WCS is in the Remote Learning mode?

Yes. Parents desiring to pick-up Free, Reduced or Paid meals during Remote or Online Learning will need to order them in advance by e-mailing the cafeteria manager of their child's school. The parents must have [pre-registered their student\(s\) for Free and Reduced meals with the Food Service Department](#) or [filled out an application with WCS](#). A form for the [WCS the meal kit is available on the WCS website](#). Parents can request five (5) days of meals. Meals can be picked-up at the school via curbside delivery. No dine-in service will be provided. Each school will schedule pick-up times. Contact the cafeteria manager of your school



to work out payment delivery options as needed.
