If your student is enrolled in a class, you will receive an email confirmation from noreply@jackrabbittech.com with the payment link.

PAYMENT DETAILS:

EWLP COST: Registration fee is \$100 per student for 12 weeks of classes.

PAYMENT: Credit card payments only.

- ❖ **DO NOT** make a payment until you have enrolled in a class. You will be directed to the Payment Portal to remit payment.

KEY DATES: Please note the following important dates for payment.

- ❖ Friday, December 20, 2024 at 3 p.m: Deadline to submit WCS Food Services approval letter to receive registration fee discount.
- ❖ Tuesday, December 31, 2024 at 12 p.m. (noon): Deadline for ALL credit card payments.

CREDIT CARD PAYMENTS: – To streamline the payment process, we are only accepting credit payments using the WCS district-wide Online School Payments system. All credit card payments will have a non-refundable 4% + .35 convenience fee per transaction. The credit card receipt will be emailed to you from Online School Payments (OSP) ospadmin@osmsinc.com. **(We do not accept AMEX credit cards.) Please pay for all students in one transaction.**
